It has been several months since the last Newsletter was issued. Work on the NPC Project has been steadily progressing throughout the winter. More information is in the Construction Update.

The TTN Annual General Meeting was held in October. CRP had a booth set up to share information with membership about the Project. Thank you to all the people who stopped to talk and ask questions on the Project. A give-away draw was held for an iPad and an iPod. The winners were Paul Archibald Sr. and Aurora Archibald. A bus tour of the New Post Creek Project Site for interested TTN members was arranged and well attended.



Chief Hardisty of Moose Cree First Nation joined Chief Dwight Sutherland and the Council of Taykwa Tagamou Nation on a visit to the project site in January with members of the Coral Rapids Power Board of Directors and Project Team.

We are very proud of the TTN members who are working on this project, as employees or contractors, and we have highlighted a few in this newsletter. CRP has another Director on our Board. I wish to welcome Waylon Iserhoff, a TTN member, who officially joined the Board in late October 2015. His qualifications, knowledge and experience in the financial field is a welcome addition to the CRP Board.

We have had six CRP Board Meetings since the last newsletter. In October 2015 I did a joint presentation with OPG on the New Post Creek Project at the (OWA) Ontario Waterpower Association conference in Niagara –on-the-Lake. CRP has been a member of this association for the past few years.

At our CRP Board of Director's Meeting in March, all the outstanding agreements required for the Partnership (Shareholders Agreement updates, the CRP Services Agreement, and OPG PM Services Agreement) were approved and signed. Our CRP Personnel Policy, Financial Policy and Conflict of Interest Policy were amended with minor updates and approved.

Our application to the (OFA) Ontario Finance Authority for the (ALGP) Aboriginal Loan Guarantee Program was submitted and we are continuing to work on obtaining this financing for our equity contribution. Our financial advisor,

New Board Member for Coral Rapids Power

Construction Update

The construction of the Peter Sutherland Sr. Generating Station has continued throughout the winter months, and significant progress has been made on many parts of the project, and new milestones have been reached recently, including the delivery and installation of the first piece of penstock. The penstock will bring water from New Post Creek down to the powerhouse.

The powerhouse sheet piles, which are used to keep water out of the foundation area, have been installed but due to the soil conditions and presence of larger than anticipated rock some could not be installed to their full depth. As a result, more pumps are required to keep the powerhouse work area free of water to allow the construction to proceed. With the additional dewatering, the powerhouse concrete is now being poured and the work is proceeding as expected.

The penstock area and intake canal were excavated during the winter to take advantage of the frozen ground. There were some challenges in preparing the intake canal area as

the slope area was less stable than expected. As a result the excavation is occurring at a slightly shallower slope, which will not affect the project overall. Ditching along the slopes and in front of the powerhouse has been completed in anticipation of excess spring water run-off.

The spillway work area on New Post Creek is now dewatered and concrete work will commence shortly.

The transmission line right-of-way (ROW) on the west

side of the Abitibi River has been cleared, poles erected, and wire strung across the full length. Discussions are currently underway to determine the alignment of the access road for the transmission line switchyard. Several options are being discussed at the Joint Working Group to determine how to best connect the project with Ontera's fiber optic line which runs close to the transmission line.

The head pond area has been cleared and non-merchantable timber is being mulched and spread on the access trails. Some of the wood will be delivered to the TTN reserve as requested once the load restrictions are lifted on the highway.

With the working experience gained from the NPC Project, TTN members were able to transition their skills to other employment opportunities.
